**These I-I passes have been created for YOU;** so that those in the pro-justice / pro-truth / pro-transparency movement (and anybody else in Ireland who has the insight, the moral courage and the will to challenge the criminality going on) can **LAWFULLY** protect themselves from **UNLAWFUL** legislation.

If you print out, sign, cut-out and fold at the arrows, you will have 3 business-card sized passes that can be laminated and carried around with you. You might also consider ordering your own business cards using this template so that you can distribute these passes to others to use, or just hand them out as replicas of your original (yellow?) laminated pass.

You **WILL** (at first) be confronted, obstructed, challenged, dismissed or ignored by 'the establishment' and by those who service them (guards, police, security personnel etc.,) but hold your ground! Demand (politely) that a garda/police comes to qualify which position has lawful precedence: (i) the deceptive (and therefore unlawful) lies of 'the establishment' as explained on [Asseveration No 020 \(full form\)](#) or; (ii) the truths, evidence and empirical proofs which have been formally and repeatedly 'served' on the government that explain how the respective legislation is based upon a massive lie, which the government has since conceded 'QTC' (silence implies consent); that there is in fact **NO** actual, genuine 'pandemic' other than a plandemic of fear, of lies, and of intimidation – contrived and manipulated – for devious, nefarious and sinister purposes, and that [Asseveration No 020 \(short form\)](#) is therefore a true and lawful assessment of the situation, which carries both the weight of truth and the force of law; as explained in [Asseveration No 001 \(full form\)](#). **Asseveration No 020** thereby completely and absolutely nullifies the referred-to Covid-19 legislation.
